

FSK e.V. (registered association) and Services GmbH General Terms and Conditions / Participation Terms and Conditions

(August 2018)

1. Scope of application

The FSK e.V. regularly commissions FSK Services GmbH to carry out and invoice its events. These GTC govern the contractual relationship between the FSK e.V. (Specialist Association Foamed Plastic and Polyurethanes), FSK Services GmbH and a participant of an event (also specialist conference, workshop) of FSK e.V. / Services GmbH.

2. Registration

Registration for an event of FSK e.V. / Services GmbH requires written form by letter, fax or in electronic form and is considered a binding offer. By registering, the participant accepts the conditions of participation.

Registrations by members of the FSK e.V. will be given priority, otherwise registrations will be considered in the order in which they are received.

Confirmation of receipt of the binding application does not constitute acceptance of the contract. The contract will only be accepted by a written confirmation of participation from FSK e. V. / Services GmbH.

3. Event fees

The event fee is per person and seminar and includes the services advertised in the event plus statutory VAT. The event fee will be invoiced to the participant and is due within two weeks of receipt of the invoice, at the latest by the start of the event. It is to be transferred to the account listed in the invoice, stating the invoice number.

If the participant is in default of payment, the organiser reserves the right to charge default costs.

4. Cancellation / Postponement of events

The organiser reserves the right to cancel or postpone events due to force majeure or for important reasons, e.g. failure / illness of speakers, insufficient number of

participants, etc. Registered participants will be informed immediately and any seminar fees already paid will be refunded. Further claims are excluded.

5. Change of speaker

A change of speaker does not entitle the participant to withdraw from the contract or to reduce the fee.

6. Cancellations

A registration can be cancelled up to 8 days, for seminars of several days up to 24 days before the beginning of the seminar, against a handling fee of € 25.-. Cancellation must be made in writing. After that, the seminar fee must be paid in full. It is possible to name a substitute participant at any time.

A participant who withdraws after the above period or does not attend or does not attend the seminar in part is generally obliged to pay the full fee. If neither the timely cancellation nor the appointment of a substitute participant occurs, the seminar fee is due in full.

7. Documents / Copyright

The participant receives documents for the seminars at the beginning of the attendance seminars. The documents are protected by copyright and may not be reproduced - not even in extracts - without the express written consent of the organiser. This applies in particular to photographs, as well as tonal or pictorial recordings of event components.

8. Data storage / Data protection

The data transmitted to FSK e. V. / Services GmbH is stored electronically. In addition, names, company affiliation and contact data in the respective attendance lists are made accessible to other registered event participants. This data storage and / or publication may be revoked in writing at any time.

FSK e. V. / Services GmbH records the event in whole or in part in sound and image. The participant / speaker agrees to the random photocopy and publication for association purposes (e.g. picture gallery on the homepage of the association, publication in the conference volume, press releases on the event). Individual recordings and interviews will only be published outside the association after consultation and approval.

9. Liability

The organiser assumes no liability for the completeness, topicality and correctness of the documents and the execution of the seminar.
